## LSZQ - Adjustment of landing charges for PWR-driven ACFT as of July 1, 2024

The board of "Société Coopérative Aérodrome du Jura (SCAJ)" plans in cooperation with the airport management a slight adjustment of the landing charges as of July 1, 2024.

Since the opening of the aerodrome June 15, 2011, the landing charges were never revised. The inflation, a slight increase in the value-added tax and a more sensible gradation between the different weight and membership classes lead to the following new rates:
